ECHO Rangers is a hands-on, educational 10-month program that showcases many of Volusia County's Ecological, Cultural, Heritage and Outdoor treasures. The program is offered to children who are in grades 1-5 as of August 2020.

**Cost:** \$20 registration fee per child

**The fee includes:**

- Admission to participating sites for the ECHO Ranger candidate and one adult
- ECHO Ranger ID badge, lanyard and T-shirt
- Official ECHO Ranger "Passport to Adventure" guidebook detailing all sites and dates available
- Admission to the graduation picnic on June 5, 2021

ECHO Rangers travel to the sites listed in their guidebooks on designated dates. There will be unique and exciting things to do at each site. After the tour, rangers get a stamp in their passport. Eight stamps (two for each letter in ECHO) will get you into the ECHO Ranger graduation picnic in June.
